Response to Commitment 13 from the Technical Meeting for the Saline Effluent Discharge to Marine Environment, Rankin Inlet, Meliadine Gold Mine, Nunavut

In response to Commitment 13 requested from the Northlands Denesuline First Nation and Sayisi Dene First Nations, Agnico Eagle has provided a list of the various Terrestrial Environment Management and Monitoring Plan (TEMMP) documents that have been, and will be, submitted as part of the Meliadine Project.

The TEMMP is designed to monitor potential residual effects of the Project on wildlife habitat, wildlife distribution, and local wildlife abundance when mitigation strategies are implemented during operations. Table 1 provides a summary of updates made to the TEMMP. The TEMMP is the overall plan that outlines the monitoring objectives, data requirements and subsequent mitigation and management outcomes within an adaptive management framework.

Table 2 provides a summary of reports submitted as part of the Annual Reporting requirements. The objectives of the Annual TEMMP Report are to summarize annual data collected from wildlife and vegetation monitoring programs, and to describe natural variation and potential Project-related impacts to wildlife populations within and adjacent to the Project. The data is collected according to procedures and sampling or monitoring intervals outlined in the Project's Standard Operating Procedures and the TEMMP. Occasionally there may be special studies or required/requested analyses that are required outside of the general TEMMP objectives and would be reported as part of the annual reporting requirements to NIRB. Annual reports are posted on the NIRB site and available for comment from intervenors.
