Having two existing company's removing material from this one and only location is and will become an issue, reasoning: Local campers having cabins to the east and south of that area are noticing it more and more each year how much the quarrying is moving closer to the ocean's high water mark and private cabins. Kugluktuk's office members should stake out the *within* boundaries for these contractors. Hopefully in the future our Lands department will also be notified as to each of the contractors time frame in this quarry pit/expiration date/quarry permit expiration dates and as well, the amount they wish to quarry adds up to what's stated on their quarry application.
