Re: Notice of Screening for Canadian Wildlife Service's "1990s Caribou Camp and Fuel Cache Clean-Up (Ahiak Migratory Bird Sanctuary)" Project Proposal

Dear Clément Chevallier:

On January 8, 2021, the Nunavut Impact Review Board (NIRB) received a referral to screen Canadian Wildlife Service's (CWS) "1990s caribou camp and fuel cache clean-up (Ahiak Migratory Bird Sanctuary)" project proposal from the Nunavut Planning Commission (Commission), which noted that the project proposal is outside the area of an applicable regional land use plan.

Pursuant to Article 12, Sections 12.4.1 and 12.4.4 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement)* and s. 87 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*), the NIRB has commenced screening this project proposal and has assigned it file number **21UN001** - please reference this file number in all future related correspondence.

INFORMATION REQUEST

On January 11, 2021, the NIRB requested that the Proponent complete the online application form through the NIRB's public registry system and ensure, pursuant to s. 144(1) of the *NuPPAA*, that sufficient information is provided to determine the scope of the project activities being proposed and commence screening.

On January 20, 2021, the NIRB released a formal correspondence, pursuant to s. 144(1) of the *NuPPAA*, requesting that the Proponent provide the Board with the information necessary in order to carry out the screening of the project proposal. On February 17, 2021, the NIRB received the required information and commenced the screening pursuant to Part 3 of the *NuPPAA*.

Summary of Project Description:	The Proponent intends to conduct a Site Cleanup/Remediation within the Ahiak Migratory Bird Sanctuary.				
Project Proposed Timeline:	August 2021 to August 2023				

According to the project proposal, the scope of the project includes the following undertakings, works or activities:

- Use of Twin Otter to remove waste from an abandoned caribou hunting camp to Cambridge Bay for disposal, including;
 - Tent frames and other camp debris;
 - 44 full drums of fuels; and
 - 23 partially full and empty fuel drums;
- Use of helicopter for transport between the camp site and Cambridge Bay;
- Use of a generator for electricity;
- Use of propane (40 liters) and gasoline (20 liters);
- The fuel and the drums from the remediation will be taken to Cambridge Bay for disposal by a local company; and
- Non-Combustible wastes, old wood tent frames, and old stove parts will be taken to Cambridge Bay for disposal by a local company.

Inclusion or Exclusion of Scoping List

At this time, the NIRB has identified no additional works or activities in relation to the project proposal. As a result, the NIRB will proceed with screening the project based on the scope as described above.

- Whether the project proposal is likely to cause significant adverse impacts on wildlife habitat or Inuit harvest activities; and if so, why;
- Whether the project proposal is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (and providing any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
