## PROJECT SCOPE:

The proposed “West Remus Creek Quarry Expansion” project is located within the Qikiqtani (North Baffin) region, approximately 400 kilometres (km) from Grise Fiord. The Proponent intends to conduct an expansion of the quarry at West Remus Creek is needed as the additional aggregate required is not available within the current permitted boundaries. The program is proposed to take place from July 2021 to October 2025. The scope of this proposed project as identified by the NIRB includes the following undertakings, works or activities:

- Conducting geotechnical surveys to determine the area of an expansion of the quarry;
- Potential construction of two temporary culvert stream crossings in the case that acceptable aggregate grade is not available in the primary expansion area;
- Hazardous and non-combustible wastes to be properly disposed of off-site at an appropriate facility; and
- Use and storage of fuel (approximately 478,000 L) for project activities.
