My name is Mia Otokiak and I am the Junior Technical Advisor that has been assigned to your NIRB Screening File Number 21QN010.

After reviewing the materials provided to the NIRB I do have a clarification question.

In the NIRB Application it is stated that 4 quarries have been identified (Quarries 1, 2, 3 and 5, with Quarry 5 being exempt from screening), in the Quarry Management Plan it is stated that “the 3 quarry sites are located near the community of Arctic Bay”, and in the NPC Conformity Determination letter it is stated that “the summary of modification is an addition of 4 new aggregate extraction locations”. Can you please clarify exactly how many quarries the GN-CGS is proposing to the NIRB? As well as update the Quarry Site Plan to reflect this information.

This information is needed to be able to move forward in the NIRB Screening process.
