Good day Michelle,

The exchange of correspondence with NITV's legal counsel and the Board's Chair that occurred on April 9 and 10 and NITV's correspondence from this morning will be filed when the Board's public registry reopens this morning. And the Board will refer to this exchange at the commencement of this morning's proceedings. However, for the clarity of NITV and all participants, the Board's position has been explained and the Board will not authorize rebroadcasts of proceedings while in decision-making for this file.

The Board has valued our on-going working relationship with Isuma TV/NITV and emphasizes that limits on making live feeds available to third party media outlets and limits on any rebroadcasting during decision-making are standard practices amongst administrative tribunals. The Board strongly disagrees with the characterization of these standard practices as "censorship", as media continue to be present and accessibility by live stream continues.
