The NIRB public hearings are intended to be just that, public. Preventing the rebroadcasting of the NIRB hearings is an affront to the NIRB's duty to consult, and in particular, the duty to consult with Inuit about what happens on their land.

Please allow Uvagut to rebroadcast and retransmit the Baffinland hearings so that all Nunavummiut have free public access to this decision-making process.
