RE: NPC File No.: 149573 [Igloolik New Power Plant]

The following works and activities have been proposed in the above-noted project proposal:

1. Construct and operate a new power plant in the Hamlet of Igloolik. Activities include a fuel storage system consisting of two 90,000 litre double-walled, fuel pumping facilities, Quonset garage, transformer storage, pole racks, oil and glycol drum storage and waste disposal area (with secondary containment berm). In addition upgrades to the existing distribution system to connect to the new power plant, 250-metre fuel pipeline will be constructed to connect to the Petroleum Products Division (PPD) bulk fuel storage facility

located to the south will be constructed. The pipeline will be a combination of aboveground and underground construction.

2. Location: Qikiqtani Region [Igloolik]

The Nunavut Planning Commission (NPC) has determined that this project proposal is outside the area of an applicable regional land use plan.
