As indicated by the Nunavut Impact Review Board (NIRB or Board) in the text accompanying the circulation of Baffinland Iron Mines Corp.'s (Baffinland) written responses and comments to Intervenor's questions associated with the Mary River "Phase 2 Development Proposal" on September 14, 2021<sup>1</sup> (Response Package), the Board has completed a detailed review of the Response Package to determine whether Baffinland's responses warrant providing an opportunity to specific Intervenor's to provide written follow up.
