This email is a follow up to the Suspension of Assessment of Activities issued by the Nunavut Impact Review Board (NIRB or Board) dated, May 20, 2020 for Canada-Nunavut Geoscience Office's "Hope Bay and Elu Greenstone Belt Mapping Project" proposal (NIRB: 20YN011; NPC: 149339).

The NIRB requests that Canada-Nunavut Geoscience Office provide an update to confirm whether the company expects to re-engage the assessment process for the "Hope Bay and Elu Greenstone Belt Mapping Project" project proposal and if so, when can the NIRB expect the material be submitted? Please note that if such a written request has not been filed by May 14, 2023 the assessment of the project will be terminated as per section 143(4) of the *Nunavut Planning and Project Assessment Act* (NuPPAA). You would then have to re-apply through the Nunavut Planning Commission (Commission).
