**Re: Termination of Assessment Activities for Agnico Eagle Mines Ltd.'s "Whale Cove Area Exploration Projects" Proposal, pursuant to NuPPAA s. 143(6)**

Dear David Frenette:

On October 27, 2021 the Nunavut Impact Review Board (NIRB or Board) received the enclosed request from Agnico Eagle Mines Ltd. to terminate the assessment of the "Whale Cove Area Exploration Projects" proposal. Pursuant to s. 143(6) of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*) [NIRB File No.: 19EN027], this letter is an official notification to all parties that the assessment of the "Whale Cove Area Exploration Projects" proposal has been **terminated** effective October 27, 2021 pursuant to s. 143(6) of the *NuPPAA*.

Should the Proponent wish to undertake the proposed project in future, a new project proposal must be submitted to the Nunavut Planning Commission in accordance with s. 76 of the *NuPPAA*. Please be advised that the *NuPPAA* prohibits the carrying out of a project, in whole or in part, where the required assessment by the NIRB has not been completed; regulatory authorities are also not authorized to issue a licence, permit or other authorizations in respect of a project where the required assessment by the NIRB has not been completed.
