**THE GROUNDS FOR THE MOTION ARE:**

1. Amaruq Hunters and Trappers Association have responsibility's as the Designated Inuit Organization as per Inuit Governance (Inuit Right) circa 1972 pertaining to Laws of Inuit on Wildlife and Environment.
2. The Inuit Tradition and Oral Decision Making are pursuant to Inuit Right and Plans that were made as implementation responsibility as set out in the Nunavut Agreement.
3. The Inuit Tradition and Oral Decision Making also recognizes the 1890's Qaggivikjuaq put in place implementation responsibility, Saimatat, by Inuit Governance known as Uqqurmiut Elders Governance circa 1878-1899, 1900 to date.
4. The Community Land and Resource Committee was created under the Inuit Tradition to oversee member or beneficiary participation by consensus and Inuit Right .
