Dear Mr. Morrison, Ms. Pirie-Dominix, Mr. Cote, Mr. Dwyer, Mr. Manzo, and Ms. Keyes:

RE: NPC File No 149637 [Cultural Resource Inventory Project]

The following works and activities have been proposed in the above-noted project proposal:

1. Scientific research: Cultural resource inventories in Migratory Bird Sanctuaries (MBSs) and National Wildlife Areas (NWAs). The teams will travel to the MBSs by boat, plane, or ATV. The team will consist of 5-10 people, including at least one Know History staff member or sub-contractor and a videographer. The group will bring tools such as video recording equipment (cameras, microphones, tripods) and camping equipment (tents, sleeping pads/bags, camp stoves with naphtha fuel). Once within the MBSs, they will travel by foot or by ATV. Gasoline for the boat and ATVs may be taken into the MBSs as part of these trips. When in the sanctuaries, the project team will maintain a safe distance from any archaeological sites. The group will also be instructed to avoid any interactions with wildlife, including known nesting, breeding, moulting, calving, and denning areas.
2. Location: Kivalliq Region [Ikkattuaq (Harry Gibbons) and Qaqsauqtuuq (East Bay) MBSs , Near Coral Harbor]

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. It conforms to the Keewatin Regional Land Use Plan (KRLUP). The proponent has undertaken to comply with the applicable conformity requirements of Appendix C, G, and H of the KRLUP. The project proposal requires screening by the Nunavut Impact Review Board (NIRB) because it does not belong to a class of exempt works or activities set out in Schedule 12-1 of the Nunavut Agreement.

The regulatory authorities to which this letter is addressed are responsible under the Nunavut Planning and Project Assessment Act (NUPPAA) to implement any of the applicable requirements by incorporating the requirements directly, or otherwise ensuring that they must be met, in the terms and conditions of any authorizations issued.

This conformity determination applies only to the above noted project proposal as submitted. Proponents may not carry out projects and regulatory authorities may not issue licenses, permits and other authorizations in respect of projects if a review by the NPC is required. Regulatory authorities may consult with the NPC to obtain recommendations on their duties to implement the existing land use plans prior to issuing licenses, permits and other authorizations under subsection 69(6) of the NUPPAA.
