## PROJECT SCOPE:

The proposed “Baker Lake Geothermal Project” is located within the Kivalliq region, Within Municipal Boundaries of Baker Lake. The Proponent intends to drill an approximate 800-meter hole into the ground and measure the amount of heat available, while identifying anything that could limit the use of the heat measured. The intention is to determine if the heat can be used for electricity to power the Hamlet to reduce or eliminate diesel use depending upon the results obtained. The program is proposed to take place from August 2022 to September 2022. The scope of this proposed project as identified by the NIRB includes the following undertakings, works or activities:

- Use of a diamond drill, with associated water pump and generator
- Use of instruments to collect data from drill hole
- Disposal of waste at hamlet landfill or transported out for proper disposal as appropriate
- Use of water from municipal service for drill operations
