#### Dear Parties:

On July 19, 2022, the Nunavut Impact Review Board (NIRB or Board) issued procedural direction and timeline for assessing Baffinland Iron Mines Corp.'s (Baffinland) "Production Increase Proposal Renewal", a proposed amendment to the approved Mary River Project (NIRB File No. 08MN053, Project Certificate No. 005). In that correspondence, the Board notified parties of an upcoming Community Roundtable that would be held in Pond Inlet as well remotely using Zoom and Teleconference. The Board is holding a Community Roundtable to gather feedback directly from community members of potentially affected communities and invited community organizations to appoint designated representatives from Pond Inlet, Igloolik, Sanirajak, Arctic Bay, Clyde River, Resolute Bay and Grise Fiord. During the Community Roundtable Agenda (Appendix A) the Board will hear questions, comments and applicable knowledge from these designated representatives. Designated representatives from all communities will be participating using the audio/ video links from their communities and given designated times in the agenda.

Interested parties unable to attend in Pond Inlet, can follow the proceedings through the audio/video access; any parties who wish to participate should contact the Board using <a href="mainto-en-info@nirb.ca">info@nirb.ca</a> as soon as practicable. Regulators are encouraged to participate to respond to community questions.
