The NIRB requests that the Ocean Wise Conservation Association provide an update to confirm whether the company expects to re-engage the assessment process for the "Eyes Above and Ears Below: Combining Technologies to Understand Killer Whale Vocal Behaviour, Group Composition and Distribution in the Arctic" project proposal and if so, when can the NIRB expect the material be submitted? You would then have to re-apply through the Nunavut Planning Commission (Commission).
