Re: Termination of Assessment Activities for Ocean Wise Conservation Association's "Eyes Above and Ears Below: Combining Technologies to Understand Killer Whale Vocal Behaviour, Group Composition and Distribution in the Arctic" Project Proposal, pursuant to NuPPAA s. 143(4)

Dear Dr. Valeria Vergara:

On April 4, 2019, the Nunavut Impact Review Board (NIRB or Board) received a referral to screen Ocean Wise Conservation Association's "Eyes Above and Ears Below: Combining Technologies to Understand Killer Whale Vocal Behaviour, Group Composition and Distribution in the Arctic" project proposal and on May 25, 2019, the NIRB received a revised referral from the Nunavut Planning Commission. The NIRB assigned this project proposal file number 19YN024 and commenced screening the project proposal pursuant to Article 12, Sections 12.4.1 and 12.4.4 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement)* and s. 87 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*).

On August 9, 2019, the NIRB suspended its assessment activities for this screening pursuant to s. 143(2) of the *NuPPAA* following a request from Ocean Wise Conservation Association to suspend the NIRB's assessment of the "Eyes Above and Ears Below: Combining Technologies to Understand Killer Whale Vocal Behaviour, Group Composition and Distribution in the Arctic" project proposal. To date, the Proponent has not requested resumption of the assessment within three (3) years of the suspension of this project proposal; therefore the assessment of the "Eyes Above and Ears Below: Combining Technologies to Understand Killer Whale Vocal Behaviour, Group Composition and Distribution in the Arctic" project proposal is hereby **terminated** pursuant to s. 143(4) of the *NuPPAA* (see [Appendix A](#) for file history).

Should the Proponent wish to undertake the proposed project in future, a new project proposal must be submitted to the Nunavut Planning Commission in accordance with s. 76 of the *NuPPAA*. Please be advised that the *NuPPAA* prohibits the carrying out of a project, in whole or in part, where the required assessment by the NIRB has not been completed; regulatory authorities are also not authorized to issue a licence, permit or other authorizations in respect of a project where the required assessment by the NIRB has not been completed.
