Hello Talia,

Thanks very much for the follow up. I apologize for our slow uptake on this application, we just recently returned from a trip to Nunavut to see our sites last week, and are in the midst of processing all of the data and information collected during the site visits.

I did want to reach out, as following our site visits, we have found that our project would see greatly improved constructability if we merely adjust it 300m to the SW, which will move it out of the way of several small areas of standing water and saturated, unstable ground. We have a bit more investigative work to undertake in order to vet the new site and weigh our options before we will be ready to proceed with a decision, however. On a related note, I do have a question: can you indicate if such a small change would require us to re-submit our application to the NPC for a re-review?

As we review this possible adjustment, we would like to hit pause on the review of this project for the time being, while we investigate the possibility of adjusting our site location. We should know more within the next 3-4 weeks. Is this possible to do?
