**Re: Notice of Screening for the Geological Survey of Canada's "Community Geological Mapping of the Kivalliq Corridor" project proposal**

Dear Mary Sanborn-Barrie:

On February 7, 2023, the Nunavut Impact Review Board (NIRB) received a referral to screen the Geological Survey of Canada's (GSC) "Community Geological Mapping of the Kivalliq Corridor" project proposal from the Nunavut Planning Commission (Commission), with an accompanying positive conformity determination with the Keewatin Regional Land Use Plan.

Pursuant to Article 12, Sections 12.4.1 and 12.4.4 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement)* and s. 87 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*), the NIRB has commenced screening this project proposal and has assigned it file number **23YN004**.

#### INFORMATION REQUEST

On February 7, 2023, the NIRB requested that the Proponent complete the online application form through the NIRB's public registry system and ensure, pursuant to s. 144(1) of the *NuPPAA*, that sufficient information is provided to determine the scope of the project activities being proposed and commence screening.

On February 17, 2023, the NIRB received the required information and commenced the screening pursuant to Part 3 of the *NuPPAA*.

According to the project proposal, the scope of the project includes the following undertakings, works or activities:

- Training and employment of local community members for the life of the project;
- Use of a helicopter for transportation of personnel to research sites from communities, and return to communities each evening;
- Use of research equipment to collect, view, record and photograph rock samples;
- Storage of fuel outside of communities, to ensure safety; and
- Use of accommodations and services within communities.

At this time, the NIRB has identified no additional works or activities in relation to the project proposal. As a result, the NIRB will proceed with screening the project based on the scope as described above.

- Whether the project proposal is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (and providing any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
