PROJECT SCOPE:

The proposed “Helicopter-based radar survey of Devon Ice Cap” project is located within the Qikiqtani region, approximately 75 kilometres (km) from Grise Fiord. The Proponent intends to conduct aerial radar surveys over Devon Ice Cap over the course of 7 to 10 days. The program is proposed to take place from April 16, 2023 to June 6, 2023. The scope of this proposed project as identified by the NIRB includes the following undertakings, works or activities:

- Use of a radar instrument mounted on a helicopter to perform radar surveys of various glaciers of the Devon Ice Cap over the course of 7 to 10 days;
- Use of a helicopter to perform test flights out of the Polar Continental Shelf Program Facility in Resolute Bay for 1 to 3 days prior to the radar survey.
- Use of a Twin Otter aircraft to deliver fuel to existing caches at Gascoyne Inlet and Truelove Lowlands.
- Storage of 10 x 200L barrels of aviation fuel at an existing fuel cache at Gascoyne Inlet.
