

<p>Transport Canada's Navigation Protection Program (NPP) reviewed this project to determine if an approval would be required under the <i>Canadian Navigable Waters Act</i> (CNWA). The proposed water intake is on Angikuni Lake, which is part of the Kazan River, a scheduled waterway under the CNWA.</p> <p>Intakes in a navigable waterway may be classified as Minor Works under the CNWA Minor Works Order if all the criteria have been met. The proponent used the NPP's Project Review Tool and determined that the project meet the Minor Works Order. The proponent posted the project to the Common Project Search Registry (#2023-609106). Minor Works do not require approval under the CNWA. Transport Canada does not require anything further for this project to proceed.</p>
