Re: Notice of Screening for Parks Canada's "Sinaasiurvik Gathering Place" project proposal

Dear Chris Doucette:

On April 6, 2023, the NIRB received a referral to screen Parks Canada's "Sinaasiurvik Gathering Place" project proposal directly from Parks Canada pursuant to s. 167 of the *NuPPAA*. On April 14, 2023, the NIRB received the complete application from the Proponent.

The NIRB notes that the proposed project would be located within the Sirmilik National Park and pursuant to s. 70(1) of the *NuPPAA*, the Nunavut Planning Commission conformity determination process does not apply.¹ As a result, pursuant to Article 12, Sections 12.4.1 and 12.4.4 of the *Nunavut Agreement* and s. 87 of the *NuPPAA*, the NIRB has commenced screening this project proposal and has assigned it file number **23CN021**.

Summary of Project Description:	The Proponent intends to set up a temporary camp to construct a permanent cabin, a camping area, and a helicopter landing area within the Sirmilik National Park, together called the Cultural Learning Centre.
Project Proposed Timeline:	May 2023 to August 2024, at least 2-4 times per year thereafter.

According to the project proposal, the scope of the project includes the following undertakings, works or activities:

- Construction and/or storage of prefabricated structures in Arctic Bay, including:
 - pre-fabricated multi-use cabin;
 - cultural learning centre;
 - flagpole;
 - outdoor seating;
 - privy; and
 - aboveground fire pit;
- Transport of prefabricated material from Arctic Bay to Sinaasiurvik by snowmobile and qamutik in spring 2023 and 2024;
- Assembly of prefabricated structures at Sinaasiurvik in summer 2023 and 2024;
- Temporary 10-person camps in summer 2023 and 2024;
- Use of helicopter for transportation of personnel and equipment;
- Use of gasoline, naphtha, and propane for camp activities and snowmobiles; and
- Ongoing use of cabin and other facilities by Parks Canada staff, visitors, and local residents.

Inclusion or Exclusion of Scoping List

At this time, the NIRB has identified no additional works or activities in relation to the project proposal. As a result, the NIRB will proceed with screening the project based on the scope as described above.

- Whether the project proposal is likely to arouse significant public concern; and if so, why;
- Whether the project proposal is likely to cause significant adverse eco-systemic or socio-economic effects; and if so, why;
- Whether the project proposal is likely to cause significant adverse impacts on wildlife habitat or Inuit harvest activities; and if so, why;
- Whether the project proposal is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (and providing any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
