Re: Comment Request for Baffinland Iron Mines Corporation's Mary River Project 2022 Annual Report

Dear Parties:

On May 3, 2023, the Nunavut Impact Review Board (NIRB or Board) received Baffinland Iron Mines Corporation's (Baffinland or Proponent) Mary River Project 2022 *Annual Report* as required by the Mary River Project's Project Certificate No. 005, Amendment No. 004. On May 18, 2023, Baffinland requested to submit a new document for their 2022 *Annual Report* and on May 19, 2023, the NIRB confirmed receipt of a complete report.

The NIRB requests that interested parties review the 2022 *Annual Report* and provide comments with respect to their jurisdiction and/or area of expertise by **July 11, 2023**.

The 2022 *Annual Report* and supplemental documents are available for review from the NIRB's Public Registry at www.nirb.ca/project/125710. Access to the documents can be made by:

- Selecting the "Documents Tab" of the Project Dashboard(s) then select the "Annual Report" category on the left pane;
- Selecting "Recent Documents" on the Project Dashboards; or
- Searching the Public Registry with the Document ID numbers identified in Appendix A.

On May 15, 2023, Baffinland also submitted the following revised draft plans for comment during this comment period. Appendix A includes the NIRB Document ID numbers for searching on the Public Registry and they have been filed with the *2022 Annual Report*.

As per Section 12.7.3 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement)*, s. 135(4) of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14 (*NuPPAA*), and the Mary River Project, the NIRB's monitoring program focuses on compliance and effects monitoring.

The NIRB requests that interested parties review the *2022 Annual Report* and provide comments with respect to their jurisdiction and/or area of expertise on the following:

1. Effects monitoring

- a. Whether the conclusions reached by Baffinland in the *2022 Annual Report* are valid; and
- b. Any areas of significance requiring further supporting information or any changes to the monitoring program which may be required.

In addition, the NIRB is requesting that Regulatory Authorities also provide comments and/or information associated with their respective mandate and jurisdiction, with respect to the following. An example format for tracking comments and Proponent responses is included in Appendix B.

2. Compliance monitoring

- a. Provide a summary of any compliance monitoring and/or site inspections undertaken in association with the Project, including specifically;
 - i. Identify the terms and conditions from the Project Certificate which have been incorporated into any permits, certificates, licenses, or other approvals issued for the Project, where applicable, and report annually to the NIRB on the status of those incorporated terms and conditions;
 - ii. A summary of any inspections conducted during the 2022 reporting period, and the results of these inspections; and
 - iii. A summary of Baffinland's compliance status with regard to authorizations that have been issued for the Project.

This information is important to assist the NIRB assess, coordinate, integrate, and ensure that the Board has the information to accurately measure effects, adequately assess compliance with terms and conditions, regulatory instruments, and agreements, and whether the project is carried out in accordance with the terms and conditions as set out in the original project certificate.
