On April 12, 2023, the Nunavut Impact Review Board (NIRB or Board) received Agnico Eagle Mines Limited's (Agnico Eagle) completed *Meadowbank Complex 2022 Annual Report (2022 Annual Report)* as required by the Meadowbank Gold Mine and the Whale Tail Pit Project Certificates No. 004 Amendment 3 and No. 008 Amendment 1, respectively.

On April 26, 2023, the NIRB requested that interested parties review the *2022 Annual Report* and provide comments with respect to their jurisdiction and/or area of expertise on whether the conclusions reached by Agnico Eagle in the *2022 Annual Report* were valid.
