Dear Parties:

On May 16, 2023, the Nunavut Impact Review Board (NIRB or Board) distributed a request for public comments on the *Draft* Scope and *Draft* Impact Statement (IS) Guidelines for the assessment of De Beers Canada Inc.'s (De Beers; the Proponent) "Chidliak Diamond Mine" project proposal.

The NIRB facilitated Public Scoping and IS Guidelines Meetings in Iqaluit, Kimmirut, and Pangnirtung between June 3-8, 2023. The enclosed Revised *Draft* Scope was updated where appropriate in consideration of the comments and feedback received during the Tour as well as comments submitted by Parties before July 17, 2023.

The comment submissions received have where appropriate, been incorporated into the enclosed Revised *Draft* IS Guidelines. The enclosed table accompanies the Revised *Draft* IS Guidelines and describes how and where submitted comments were addressed or where topics will be discussed at the Guidelines Workshop.

## COMMENT REQUEST – REVISED *DRAFT* SCOPE AND REVISED *DRAFT* IS GUIDELINES

It is the NIRB's intention that the Scope and IS Guidelines provide instruction to the Proponent for its preparation of the Impact Statement that addresses information requirements for both the NIRB and the public in order to allow for a thorough impact assessment of the Project.

The NIRB asks that interested parties and Responsible Authorities review the enclosed Revised *Draft* Scope and Revised *Draft* IS Guidelines and provide comments to the Board based on their area of expertise and/or mandate on or before **noon on Tuesday, August 22, 2023**.

All parties are asked to ensure that their comments identify the following:

- The issue of concern,
- A rationale of the issue's importance to the environmental assessment process,
- Identify which section(s) of the IS Guidelines to which that concern is addressed, i.e., page number, section number, or item number, and
- Clearly identify the edits being suggested, i.e., any items that should be included, removed, or suggested changes in wording associated with the issue specifically in Sections 8 and 9.

## NEXT STEPS

The NIRB has scheduled an IS Guidelines Workshop in Iqaluit on August 28 and 29, 2023, for further discussions regarding technical matters raised through comments on the documents and to draw upon the expertise and advice of various parties in finalizing the Scope and the IS Guidelines.
