RE: NPC File No 150121 [Lake Geraldine Dam Structural Upgrades]

The following works and activities have been proposed in the above-noted project proposal:

1. Municipal activities: Amendment to NWB Water License No: 3AM-IQA1626 to accommodate Lake Geraldine dam structural upgrades works. Activities include crack injection work within localized areas, placement of 44 m3 of rip-rap material on the upstream face of the center and north berms, and construction of a cast-in-place concrete weir.
2. Related NPC File No: 148839, 149007, 149423 , Related NIRB File No:13UN034, 19WA006, and 19UN013; related NWB File No: 3AM-IQA1626
3. Location: Qikiqtani Region [Lake Geraldine, within City of Iqaluit municipal boundaries]

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. The NPC has determined that this project proposal is outside the area of an applicable regional land use plan, and the works and

activities listed above were previously screened by the Nunavut Impact Review Board including the water supply facility (NIRB FILE NO.: 13UN034, 19WA006, and 19UN013).

The above-noted project proposal is exempt from screening by the NIRB because the NPC is of the understanding that the amendment of water license 3AM-IQA1626 to accommodate the proposed works for Lake Geraldine dam structural upgrades does not change the general scope of the original or previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply.
