Re: Acknowledgement of the 2022 Annual Report for Defence Construction Canada's "Nanisivik Naval Facility" Project

Dear Nicolas Billette:

Please be advised that the Nunavut Impact Review Board (NIRB or Board) received Defence Construction Canada's (DCC) 2022 Annual Report for the "Nanisivik Naval Facility" project on March 7, 2023, as required pursuant to the Monitoring and Reporting Requirements condition 1 of the Screening Decision Report, dated October 24, 2013.

Monitoring and Reporting Requirements Condition 1 states:

1. *The Proponent shall submit a comprehensive annual report to the Nunavut Impact Review Board by March 30 of each year of construction activities as well as potentially operation activities, upon request. The annual report must contain, but is not limited to, the following information:*
 - a. *A summary of activities undertaken for the year, including:*
 - i. *an updated map showing the infrastructure at the Nanisivik Naval Facility;*
 - ii. *a description of aggregate source(s) used for the site development including the location of sources and the type and amounts of material extracted; evidence of existing, and potential for future thermokarst development, ice lenses, flooding, erosion, sedimentation, and slumping, as well as related control measures; and if blasting, a description of methods employed;*
 - iii. *a description of local hires, contracting opportunities and initiatives; and*
 - iv. *upon request, updates with respect to annual operations including the number of vessels that utilized the facility;*
 - b. *A summary of community consultations undertaken throughout the year;*

- c. *Information regarding the passive cathodic protection method that is proposed to be installed at the wharf/jetty. Information should include a discussion of protection measures taken as well as any confirmation received from Fisheries and Oceans Canada that components of the marine water environment that occur or are found within the vicinity of the wharf/jetty will not be adversely affected by this installation;*
- d. *Summary of how the Proponent has met the recommended terms and conditions; and*
- e. *Site Photos.*

Upon review of Defence Construction Canada's 2022 Annual Report for the "Nanisivik Naval Facility" project submission, the following deficiencies have been identified:

- An updated map showing the infrastructure at the Nanisivik Naval Facility; **please provide the updated maps.**
- A description of aggregate source(s) used for the site development including the location of sources and the type and amounts of material extracted; **please provide this description.**
- A summary of community consultations undertaken as detailed in the NIRB Screening Decision Report; **please indicate if these activities occurred or not.**
- Information regarding the passive cathodic protection method that is proposed to be installed at the wharf/jetty. Information should include a discussion of protection measures taken as well as any confirmation received from Fisheries and Oceans Canada that components of the marine water environment that occur or are found within the vicinity of the wharf/jetty will not be adversely affected by this installation; **please provide this information.**
- A Summary of how the Proponent has met the recommended terms and conditions; **please provide this summary.**
- Site photos; **please provide site photos.**

This information was not included in the 2022 Annual Report as required by Monitoring and Reporting Requirements condition 1 of the NIRB's October 24, 2013, Screening Decision Report.
