**RE: NANUQ NORTH PROJECT - NIRB FILE 09EN011 – ANNUAL REPORT CALENDAR YEAR 2023**

Peregrine Diamonds Ltd. (Peregrine) was purchased by De Beers Canada Inc. (De Beers) in September 2018 and is now a wholly owned subsidiary of De Beers.

The following letter is the annual Nunavut Impact Review Board (NIRB) report for the Nanuq North Project (file #09EN011) for calendar year 2023.

**Project Location**

The Nanuq North Project is located 300 kilometers north-northeast of Rankin Inlet in the Kivalliq Region of Nunavut. All activities occur within the confines of 1:50,000 scale national topographic sheets 56G07, 56G10 and 56G11.

**Project Permits & Licencing**

Peregrine holds class “A” land use permit N2018C0014 from CIRNAC which commenced on July 7, 2018 and expires on July 6, 2025. The permit authorizes an exploration camp and surface exploration activities at the Nanuq North Project. The project was assigned file number 09EN011 by the NIRB in 2009.

## Fieldwork 2023 & Project Status

No fieldwork was conducted in 2023. The Nanuq North Project is currently on care and maintenance.

## Project History

The Nanuq North mineral claims were recorded in October 2004. The first field program consisted of a fixed-wing airborne geophysical survey in 2007 during the summer of 2007. The first drilling occurred in 2008 and the last drilling/field program occurred in 2011. The Phoenix kimberlite was discovered in 2010.

Project expenditures on the Nanuq North Project are in excess of \$2,000,000.00.

## Mineral Tenure

The project consisted of 51 mineral claims with an aggregate area of 33,056 hectares. On January 30, 2021 the Nunavut Mining Regulations were changed to an electronic grid based systems. This resulted in an increase in project area by 36% to approximately 45,000 hectares. These claims were subject to a section 51 suspension of work requirements issued by the Nunavut Mining Recorder.

Peregrine suspended all exploration activities on the Nanuq North Project because recent editions of the draft Nunavut Land Use Plan have designated much of the project area as prohibited to mining and exploration.

## Project Infrastructure

One field camp is authorized at the Nanuq North Project but was never constructed. The coordinates for the Indicator Camp are below in Table 1. Past programs were based out of the Nanuq Camp which is on the adjacent Nanuq Project and authorized under a different land use permit.
