Re: Opportunity to Address Comments Received Regarding Agnico Eagle Mines Limited's Meliadine Gold Mine Project 2023 Annual Report

Dear Sara Savoie:

On March 31, 2024, the Nunavut Impact Review Board (NIRB or Board) received Agnico Eagle Mines Limited's (Agnico Eagle) completed *Meliadine Gold Mine Project 2023 Annual Report* (2023 Annual Report) as required by Project Certificate No. 006 Amendment 2.

On April 19, 2024, the NIRB requested that interested parties review the 2023 Annual Report and provide comments with respect to their jurisdiction and/or area of expertise by June 3, 2024 on whether the conclusions reached by Agnico Eagle in the 2023 Annual Report were valid. Furthermore, parties were requested to comment on the Proponent's compliance status regarding authorizations that have been issued for the Project Certificate.
