Dear Honourable Minister:

On April 27, 2026, the Nunavut Impact Review Board (NIRB or Board) received a referral pursuant to the Nunavut Agreement and *NuPPAA* to conduct a screening<sup>1</sup> of Université Laval's "Iqaluit Cod Derby Science Project" proposal and after completing the required process, the NIRB determined<sup>2</sup> that **a review of the project is not required** and recommended specific terms and conditions<sup>3</sup>.

The attached Screening Decision Report provides the regulatory framework, scope of proposal and Board's assessment process, public engagement, factors relevant for the determining significance of impacts, and recommended project-specific terms and conditions.
